APPLICATION INSTRUCTIONS FOR INTERNATIONAL STUDENTS SPRING SEMESTER 2023

ASIA EASTERN UNIVERSITY OF SCIENCE AND TECHNOLOGY

一、申請資格/I. Qualifications for Application

- (一)申請人具外國國籍且未曾具有中華民國國籍,符合下列規定者,得依教育部 「外國學生來臺就學辦法」規定申請入學:
 - 1. 未曾以僑生身分在臺就學。
 - 2. 未於申請入學 111 學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

Eligible applicants refer to those who possess foreign nationality and have never possessed the nationality of the Republic of China who meets the following requirements, qualified to apply for admission under MOE "Regulations Regarding International Students Undertaking Studies in Taiwan".

- 1. Must neither have studied in Taiwan as an overseas Chinese student.
- 2. Did not apply for admission according to "Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan" nor have been distributed by the Overseas Joint Recruitment Committee in the 2022 academic year.

具外國國籍並符合下列規定,且最近連續居留海外六年以上者,亦得依教育部「外國學生來臺就學辦法」規定申請入學。但擬就讀大學醫學、牙醫、或中醫學系者,其連續居留年限為八年以上:

An individual of foreign nationality who meets the following requirements and has recently resided overseas continuously for no less than six years is also qualified to apply for admission under *MOE Regulations Regarding International Students Undertaking Studies in Taiwan*. However, an individual who plans to apply for study at a department of medicine, dentistry or Chinese medicine must have resided overseas continuously for no less than eight years.

1.申請時兼具中華民國國籍者,應自始未曾在臺設有戶籍。

Applicants who possess the nationality of the Republic of China at time of application must never have held household registration in Taiwan. 2.申請前曾兼具中華民國國籍,於申請時已不具中華民國國籍者,應自內政部許可喪 失中華民國國籍之日起至申請時已滿 8 年。

As for applicants who once held and have renounced the nationality of the Republic of China, their renunciation must have been approved by Ministry of Interior for over eight years at time of application.

3.前二款均應符合前項第一款及第二款規定。

Applicants who meet the previous two requirements shall meet the requirements of the first and second paragraphs of the preceding paragraph.

依教育合作協議,由外國政府、機構或學校遊薦來臺就學之外國國民,其自始未曾在 臺設有戶籍者,經主管教育行政機關核准,得不受前二項規定之限制。

As recommended by foreign governments, institutions or schools to study in Taiwan under educational cooperation agreements, foreign citizens who never have held household registration in Taiwan are not subject to the aforementioned two restrictions if approved by the competent educational authority.

第二項所定六年、八年,以擬入學當學期起始日期(二月一日或八月一日)為終日計算之。

The six-year and eight-year period as prescribed in Paragraph 2 shall be calculated from the starting date of the semester (February 1st or August 1st) as the designated due date for the time of study.

第二項所稱海外,指大陸地區、香港及澳門以外之國家或地區;所稱連續居留,指外國學生每曆年在國內停留期間未逾 120 日。連續居留海外採計期間之起迄年度非屬完整曆年者,以各該年度之採計期間內在國內停留期間未逾 120 日予以認定。但符合下列情形之一且具相關證明文件者,不在此限;其在國內停留期間,不併入海外居留期間計算:

The aforementioned term "overseas" refers to countries or districts other than the mainland China, Hong Kong and Macau; the term "consecutively living" refers to the requirement that international students' stay in Taiwan may not yet exceed 120 days per calendar year. If the starting and ending dates are in two different calendar years, their stay in Taiwan should not exceed 120 days within the calculated calendar year period. The only

exceptions to this method of calculation are for those who fulfill one of the following requirements with written supportive document:

- 1.就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。 Attended overseas youth training courses organized by the Overseas Compatriot Affairs Council or technique training classes accredited by the Ministry of Education (the "Ministry");
- 2.就讀教育部核准得招收外國學生之各大專校院華語文中心,合計未滿二年。 Attended a Mandarin Chinese language center at a university/college of which foreign student recruitment is approved by the Ministry, and to which the total length of stay is less than 2 years;
- 3.交換學生,其交換期間合計未滿二年。
 Exchange students, whose total length of dates of exchange is less than 2 years; or 4.經中央目的事業主管機關許可來臺實習,實習期間合計未滿二年。

An Internship in Taiwan which has been approved by an authorized central government agency, to which the total length of stay is less than 2 years.

具外國國籍並兼具中華民國國籍,且於中華民國 100 年 2 月 1 日修正實施前已提出 申請喪失中華民國國籍者,得依原規定申請入學,不受第二項規定之限制。

Applicants with foreign nationality who once possessed ROC nationality and had renounced it prior to the revision and enforcement of the Regulations of February 1, 2011 are entitled to apply for admission under the former Regulations without being subject to the aforementioned restrictions.

- (二)具外國國籍,兼具香港或澳門永久居留資格,且未曾在臺設有戶籍,申請時於香港、澳門或海外(不含大陸地區)連續居留滿六年以上。
 An individual of foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macau, having no history of a household registration record in Taiwan and, at the time of application, has resided in Hong Kong, Macau, or another foreign country (excluding Mainland China) continuously for no less than 6 years.
- (三)曾為大陸地區人民具外國國籍且未曾在臺設有戶籍,申請時已連續居留海外 (不含香港、澳門及大陸地區) 六年以上。

An individual being a former citizen of Mainland China who holds a foreign

nationality and has no history of household registration record in Taiwan, and at the time of application, has resided overseas continuously for no less than 6 years.

(四)外國學生須符合教育部所採認之高中、專科、大學或獨立學院畢業者。具高中 (職)畢業資格者,得申請入學本校四年制學士學位班;具專科畢業資格者,得申 請入學本校二年制學士學位班;具大學畢業資格者,得申請入學本校碩士學位 班。

Applicants must be graduates from a high school, junior college, university or college recognized by the Ministry of Education. High school (vocational high school) graduates are eligible to apply for 4-year bachelor's programs at this School; junior college graduates are eligible to apply for 2-year bachelor's programs at this School; university and college graduates are eligible to apply for master's programs at this School.

(五)畢業年級相當於臺灣高級中等學校二年級之國外或香港澳門地區同級同類學校 畢業生得申請本校學士班,惟入學後依本校學則規定應補修學分數下限為 12 學分,應修習之課程由各系訂定。

Those having completed study at an equivalent foreign or Hong Kong/Macau high school which is equal to sophomore of a senior high school in Taiwan may apply to the undergraduate program at AEUST, however, according to "AEUST Study Regulations", they must take a minimum of 12 additional credits in courses as designated by the relevant department.

(六)相關入學辦法須符合教育部外國學生來臺就學辦法及相關規定辦理。
Related enrollment regulations must comply with the International Students Studying in Taiwan regulations from the Ministry of Education and with other regulations.

備註:中華民國《國籍法》第二條

有下列各款情形之一者,屬中華民國國籍:

- 一、出生時父或母為中華民國國民。
- 二、出生於父或母死亡後,其父或母死亡時為中華民國國民。
- 三、出生於中華民國領域內,父母均無可考,或均無國籍者。

四、歸化者。

前項第一款及第二款之規定,於本法修正施行時未滿二十歲之人,亦適用之。

Note: Article 2 of the "Nationality Act":

A person shall have the nationality of the Republic of China under any of the conditions provided by the following subparagraphs:

- 1. His/her father or mother was a national of the Republic of China when he/she was born.
- 2. He/she was born after the death of his/her father or mother, and his/her father or mother was a national of the Republic of China at the time of death.
- 3. He/she was born in the territory of the Republic of China and his/her parents can't be ascertained or both were stateless persons.
- 4. He/she has undergone the naturalization process.

Preceding Subparagraph 1 and 2 shall also apply to the persons who were minors at the time of the amendment of this Act.

Academic Dates: An academic year begins on August 1, ends on July 31 of the following year; the first semester begins in mid-September, the second semester begins in mid-February.

- (三)入學時間: 秋季班(9月入學)、春季班(2月入學),每學年包含2個學期。 An academic year consists of two semesters: The first semester (Fall) begins around in the middle of September ending in the middle of January, and the second semester (Spring) begins around in the middle of February ending at the end of June.
- (四)春季班入學與同年級一起授課,無另開班。
 International applicants admitted to the spring semester will attend classes with their peers of the same grade level. No extra course is offered.
- (五)本校教學以中文為主,申請者應具備中文聽、說、讀、寫能力。

 Mandarin Chinese is the major instructional language used in this school; applicants should be capable of listening, speaking, reading and writing in Mandarin Chinese.

七、申請應繳資料/VII. Application Documents Required

申請人應於 2022 年 12 月 5 日前,檢附下列表件於線上申請。

Applicants have to upload the following documents on

(一)入學申請表:請上傳最近3個月內二吋半身照片。

Application Form: Please upload your recent 2 inch × 2 inch bust photograph [taken within 3 months].

(二)最高學歷或同等學力證明文件及成績單:須經我國駐外使領館、代表處、辦事 處或其他經外交部授權機構(簡稱駐外機構)驗證。中、英文以外之語文之成績 單,應附中文或英文譯本。

應屆畢業者,申請時不需上傳畢業證書,但須上傳當學期英文版在學證明。經 我國駐外館處驗證蓋章之畢業證書正本須於錄取報到時繳交,否則取消入學資格。

※附註:如在申請截止日前無法完成驗證手續,請繳交「文件驗證切結書」(如附表 4),若經錄取,須於報到註冊時繳交經我國駐外館處、行政院設立或指定之機構或委託之民間團體驗證之畢業證書及成績單正本,未能如期繳交者,將取銷其錄取資格。

Certificate of Highest Academic Attainment or Equivalent Qualification and Transcript: The certificate must be authenticated by an ROC embassy, consulate, economical and cultural office, representative office or other organizations authorized by the Ministry of Foreign Affairs (hereinafter referred to as "overseas representative institutes"). Transcripts in languages other than Chinese and English must be submitted with

authenticated Chinese or English translation.

Applicants graduating in current semester may not be able to upload the diploma. However, they shall upload the certificate of study (certificate of enrollment) of the current semester in English and then submit their original diplomas which are authenticated and stamped by ROC overseas representative offices on enrollment, or their admission qualification shall be denied.

*Remark: If the verification process is not completed before the application deadline, a signed Affidavit (of Admissions Documents to be Verified) (please refer to Attachment 4) must be submitted with the application. At the time of registration, students must provide the original academic degree and transcript verified by a Taiwan overseas representative office, or verified by an institute established or appointed by, or through a private agency commissioned by, the Executive Yuan. If all the required documents cannot be submitted on time, the admissions offer will be revoked.

- 1.大陸地區學歷:應依大陸地區學歷採<mark>認辦法規定辦理。</mark>
 Academic credentials from Mainland China: The Regulations Governing the Accreditation of Schools in Mainland China shall apply.
- 2.香港或澳門學歷:應依香港澳門學歷檢覈及採認辦法規定辦理。
 Academic credentials from Hong Kong or Macau: Academic Credential Verification and Accreditation Methods adopted in Hong Kong and Macau shall apply.
- 3.其他地區學歷:

Academic credentials from other areas:

- (1)海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。
 Academic credentials earned at overseas Taiwan schools or Taiwan schools in Mainland China shall be regarded as the same as those at domestic schools with equivalent levels.
- (2)前二目以外之國外地區學歷,應依大學辦理國外學歷採認辦法規定辦理。但 設校或分校於大陸地區之外國學校學歷,應經大陸地區公證處公證,並經行 政院設立或指定之機構或委託之民間團體驗證。

Academic credentials referred in the preceding 2 Items shall be subject to the Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education. However, academic credentials earned from schools or branches established in Mainland China by foreign schools shall require public notarization in Mainland China and be verified and examined by an institute established or appointed by, or through a private agency commissioned by the Executive Yuan.

(三)三個月內足夠在臺就學之財力證明,或政府、大專校院或民間機構提供全額獎助學金之證明。若財力證明非申請者帳戶,需檢附資助者之財力保證書並敘明兩者關係。(本簡章附表 5)

Financial proof that shows financial sustainability for study within 3 months in Taiwan, or proof of full scholarship provided by a government agency, university, college, or private organization.

If you have a sponsor to satisfy the financial obligation, then your sponsor must provide a letter declaring their relationship to the applicant and their intent to provide financial support throughout his/her period of study. (please refer to Attachment 5)

 International Student Affidavit (please refer to Attachment 3)
- (七)申請就讀時,應提供基本語文能力證明;華語部分以「華語文能力測驗」 (TOCFL)成績2級以上能力證明或華語班2級研習結業證書為準。無華語文能力測驗基礎級(Level 2)以上證明者,應參與本校開辦之華語文輔導課程。(以中文為母語者免附)

Applicants should provide a certificate of language proficiency in Chinese when applying for admission. For admission to a Chinese-taught program, a TOCFL (Test of Chinese as a Foreign Language) certificate for Level 2 or above, or a certificate of completion of a Chinese program at Level 2 is required. Applicants who don't have a TOCFL certificate for Level 2 or above must take the Chinese courses offered by AEUST. (Native Chinese speakers are exempt from this requirement.)

- (八)含學習動機、期限及未來展望之中文或英文留學計畫書一份。
 A study plan or personal statement written in Chinese or English includes the purpose, duration, objectives and expectations.
- (九)其他有利申請之文件 (非必要)
 Other reference documents (applicants are free to attach any additional documents which may favor the application.)
- (十)越南生申請就讀時,應提供基本外語能力(華語或英語)證明;華語部分以「華語文能力測驗」(TOCFL)成績2級以上能力證明或「臺灣教育中心」華語班2級研習結業證書為準;英語授課學程需托福(TOEFL)iBT26分、多益(TOEIC)375分、雅思(IELTS)3.0分以上。

Vietnamese applicants should provide a certificate of language proficiency in Chinese or

English when applying for admission. For admission to a Chinese-taught program, an applicant should provide a TOCFL (Test of Chinese as a Foreign Language) certificate for Level 2 or above, or a certificate of completion of a Chinese program at Level 2 issued by the Taiwan Education Center. For admission to an English-taught program, an applicant should provide a TOEFL IBT score report (at least 26), a TOEIC score report (at least 375), or an IELTS score report (an overall band score of 3.0 or higher).

- (十一) 依規定至駐印尼代表處申請赴台就讀大學之外籍學生須檢附語文能力證明。語 文 能力證明(以下擇一):
 - 1.「華語文能力測驗」(TOCFL):能力 2 級(A2)以上。
 - 2. 托福成績(TOEFL):網路測驗(iBT)26 分以上或紙筆測驗(ITP)385 分以上。
 - 3. 多益成績(TOEIC): 375 分以上。
 - 4. 雅思成績(IELTS): 3.0 分以上。

Foreign students, who apply for studying in college in Taiwan at Indonesian Economic and Trade Office to Taipei as prescribed by regulations, have to attach language ability certification, which is regulated to be one of the following:

- 1. TOCFL, above level A2.
- 2. TOEFL, above iBT score of 26 or ITP score of 385.
- 3. TOEIC, above score of 375.
- 4. IELTS, above score of 3.0.

Note: No application fee required.

八、注意事項/VIII. Important Reminders

(一)申請以一系所為限,申請人應注意申請資格之各項規定。

Applicants can only apply for one degree program at one time and need to follow all the application requirements.

(二)外國學生凡已在國內完成申請就學以操行或學業成績不及格、違反法令或校規 情節嚴重致遭退學或喪失學籍者,不得再向本校申請入學。若違反此規定並經 查證屬實者,撤銷其入學資格。

An international student who is dismissed from a university or tertiary college after admission as a result of unsatisfactory conduct, or poor academic performance, or a conviction in criminal case proceedings is not permitted to re-apply for admission at this school. Verified violation of the rules on the applicant's part shall result in disqualification.

- (三)本校教學以中文為主,申請者應具備中文聽、說、讀、寫能力。

 Mandarin Chinese is the major instructional language used in this School; applicants should be capable of listening, speaking, reading and writing in Mandarin.
- (四)已錄取之學生,如經發現申請資格不符規定或所繳交之證明文件有假借、冒用、偽造、或塗改者,即取消入學資格,且不發給任何學歷(力)證明。如在畢業後始發現上述情事者,除勒令繳回撤銷其學位證書外,並公告取消其畢業資格。 If an admitted student is found disqualified, or the certificates submitted found misidentified, counterfeited, forged or altered, admission status of the said student shall be cancelled immediately, and no certificates of academic attainment or equivalent qualification shall be issued. If the above violations are found after the student has graduated, the diploma conferred shall be withdrawn and the graduate status shall be cancelled through announcement.
- (五)本簡章中英文版本如有出入時,以中文版為準。如有未盡事宜,悉依教育部「外國學生來臺就學辦法」、本校「外國學生入學規定」或招生委員會議決議處理。 If there are any discrepancies in interpretation between the English and Chinese texts, the Chinese version applies.
